NOTICE TO THE SHAREHOLDERS OF ARTEMIS FUNDS (LUX) – GLOBAL EMERGING MARKETS (THE "FUND")

Subject: Change of name of the Fund

Dear Shareholder,

We are writing to advise you that the Board of Directors of the Company has decided to change the name of the Fund, as follows:

Existing name	New name
Artemis Funds (Lux) – Global Emerging Markets	Artemis Funds (Lux) – SmartGARP Global Emerging Markets Equity

In addition, an explanation of the SmartGARP process, as further described below, will be inserted in the "Investment Policy" section of the Fund's Appendix in the Company's prospectus (the "Prospectus").

Why is Artemis making this change?

The Fund is managed with Artemis' in-house "SmartGARP[®]" software tool, which screens the market to help the managers identify companies with the most attractive financial characteristics. The Fund is, of course, actively managed – before investing, the managers undertake further detailed research to ensure that the investment rationale behind a SmartGARP recommendation is valid.

Following a review across the wider fund range, Artemis Investment Management LLP ("**Artemis**") intends to group together those investment funds that employ the SmartGARP process by including "SmartGARP" in their names. This change will help investors more readily identify those funds which are managed in a similar style with SmartGARP input. This change would also help differentiate those funds from the rest of the Artemis fund range and provide 'future-proofing', should any new funds be developed by Artemis which will invest in the same asset class but with a different investment approach.

SmartGARP is a registered trade mark of Artemis Investment Management LLP

In addition, Artemis believes that adding “Equity” to the Fund name helps to clearly describe the asset class that the Fund invests in and will ensure consistency across the group of Artemis funds which are managed in a similar style with SmartGARP input.

There will be no changes to the way in which the Fund is managed as a result of this change. The Fund’s name change will be included in the next update of the Prospectus dated 30 April 2021 and the KIIDs in relation to the Fund. Copies of these may be obtained from www.artemisfunds.com.

When will the changes take place?

The change will come into effect on 28 May 2021. You do not have to take any action as a result.

How will investors be impacted by this letter?

As explained above, there should be no impact on you as a result of this change and there will be no change to the way in which the Fund is managed, to the asset allocation of its portfolio nor to its risk profile.
